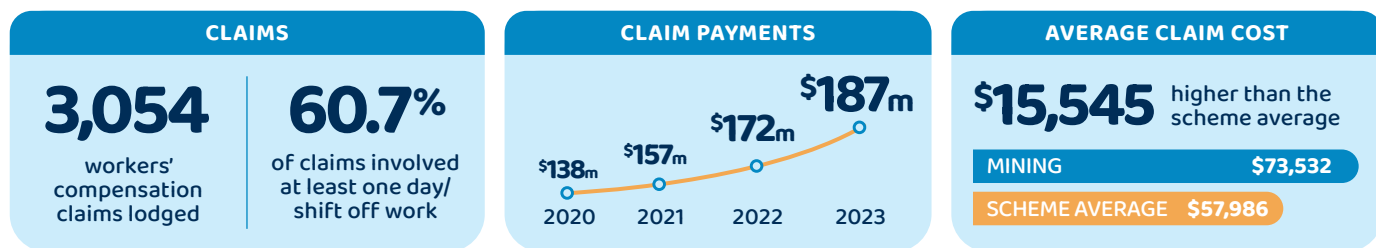

Real Insurance for Real Risks

Type of Cover	What it protects
Mobile Plant & Equipment	Covers drill rigs, compressors, and blast trucks against damage, theft, and breakdowns. Includes transport between sites and on-site operations.
Contract Works	Protects drilling and blasting contracts from equipment failure, weather delays, or project interruption. One policy covers all parties.
Workers Compensation	Required by law. Pays medical bills and wages when drillers, shotfirers, or crew get injured. Covers rehabilitation costs.
Public Liability & Contractual Liability	Protects against blast damage claims, flyrock incidents, or drill rig accidents that injure people or damage property. Covers legal costs and compensation.
Management Liability	Protects owners and directors from personal financial loss when sued over safety violations, employment issues, or business decisions.
Environmental Risk	Covers cleanup costs from drilling fluid spills, groundwater contamination, or blast-related environmental incidents and regulatory penalties.
Professional Indemnity	Protects against claims that your shot design, drilling services, or technical advice caused client losses. Covers legal costs.
Cyber Insurance	Covers costs from hacking, ransomware attacks, or system downtime affecting drill pattern software or business computers.
